



Report of Public Health Nurse

DIVISION OF PUBLIC HEALTH NURSING

DEPARTMENT OF HEALTH AND WELFARE

January 1 to December 31, 1957

A generalized Public Health Nursing Program has, as in previous years, been carried on in your town. Each taxpayer of your community, directly or indirectly, bears the cost of this service and should be interested in a sound health program for this town.

We continually strive to promote the best health and welfare in each individual. Hence, home visits have been made to prenatal, postnatal, infants, preschool, and school children this year.

Three very successful Child Health Conferences were held in September, October, and November. Children were given at least one complete physical in addition to the immunizations for whooping cough, diphtheria, tetanus smallpox, and polio.

In the school program a polio vaccine clinic was held in January with a total of 325 children receiving either the second or third immunizations.

Children in your town have profited by the Pediatric, Crippled Children, Cardiac, and Hard of Hearing Clinics sponsored by the Maternal and Child Health Division of the State Department of Health and Welfare. Referrals are made by the family physician for these services.

For many years my plea for teamwork through a local Health Council has been in vain. This is a goal toward which we should work in the ensuing year.

Your public health nurse is most grateful to those who have assisted in local projects this past year.

Carmel School Lunch Room opened September ninth with Mrs. Opal Smith, Director.

I, Henry Noonan, started at Carmel Hot Lunch November twenty-sixth working the remaining three days of school in November.

The first week in December a new deep freeze arrived, purchased on the advice of Mrs. Opal Smith's annual report of the Town of Carmel.

During the Christmas Holidays, I painted the new fire exit door casing and touched up the rest of the paint in the Hot Lunch room. I also cleaned said room for the opening of the Winter term.

A blower fan was recommended in last year's report, but the State of Maine has required that a fire wall be installed between the ranges and the dining area; therefore I deem it advisable to await installation of said fire wall to derive the most effective ventilation. I do believe a blower fan is the next step to improve your Hot Lunch Program.

There is a decrease in the number of children served and children served free this year. This decrease is believed attributed to the program's opening a week later in September and also to the fact that there has been a large number of cases of flu, measles, mumps, and chicken pox.

Report of the Superintendent of Schools

Herewith is presented the annual report of your Superintendent of Schools. The following enrollment figures are correct for February 7, 1958.

Sufficient funds were appropriated at the last annual meeting to provide an additional room and teacher for the grammar school. Your S.S. Committee gave considerable thought to the situation and, I think, acted wisely in making their decision.

We were confronted with 2 major unexpected repair bills. I refer to the fireproof wall around the furnace and the lunchroom exit at the grammar school. We were also aware of a decrease in enrollment at the high school.

It was felt that making an additional room in the present grammar school would be a temporary measure and would lessen its effectiveness as a school for the larger administrative unit.

After consultations with the teachers concerned, your committee decided to move grade 6 from the grammar school to the high school. This situation, although not the best, is working out satisfactorily.

Your S. S. Committee has taken an active interest in all phases of our educational program, and I would call your attention to some of the things for which they have been responsible:

1. A fireproof wall for grammar school furnace.
2. An exit from the lunch room.
3. Your Superintendent has been available 1 day each week at the grammar school office.
4. The driveways to both village schools have been tarred.
5. Septic tanks have been cleaned and treated with yeast.
6. Bushes have been cut and grounds improved at the grammar school.
7. Many old desks have been repaired.
8. The tops of desks have been sanded and varnished.
9. Glass has been set with putty.
10. Interior painting has been done.

The last five mentioned above were made possible by a full time janitor and maintenance man. We can well afford a full time man for this responsible position with an increase in salary over what we are now paying.

There has been a question in the minds of some people concerning the comparison of costs of operating an owned versus a rented school bus. We now have completed a full year with 1 of each type bus. During this past year we have paid Hudson Bus Lines \$3,366.76. For the same period we have spent \$2,212.01 on our own bus. The difference of \$1,154.75 does not surprise me. Private owners do not get a 62% subsidy on the purchase price.

Our sub-primary costs, correctly determined, would be approximately 1/5 of the cost of operating our elementary schools or \$2,613.18. To look at it another way, the increase in cost of instruction alone for including Sub-Primary this year, would be 38% of \$1,400.00 or \$532.00. Either way you look at it, I believe it is money well spent. Future State Subsidy will be greater for towns having a Sub-Primary.

Concerning the larger administrative unit - I have high hopes that within a year Carmel will be operating as a member of such a unit. We are represented on eight study groups for a union of six towns.

Art. 20. To see if the town will vote to discontinue the following roads as town roads and leave them private ways. The road leading from Ash hill to T. R. Murrays, known as the South County road, also the road leading from the Horseback to the Stetson Town line, known as the North County road or Pomeroy road.

(Budget Committee Recommends Yes.)

Art. 21. To see if the Town will vote to declare all School Board Member Offices vacant, and elect three (3) new members.

(Budget Committee Recommends Pass.)

Art. 22. To see if the Town will vote to hire residents of the Town for the following: School Janitor, School Bus Drivers, School Cafeteria.

(Budget Committee Recommends Pass.)

Art. 23. To see if the town will vote to unite with several other towns under the Sinclair Foundation School Bill.

(Budget Committee Recommends Yes.)

Art. 24. To transact any other business that may legally come before the meeting.


